EXPRESSION OF INTEREST FOR DREDGING WORK AT DIFFERENT TRIBUTARIES OF RIVER BRAHMAPUTRA IN ASSAM, INDIA

Water Resources Department is a Government organisation of Assam. The work of Dredging and removal of Silt is required to be done at regular interval to maintain the requisite level at different tributary of river Brahmaputra.

A. SCOPE OF WORK

1. The scope covered shall consist of removal, transportation & disposal of soft/ hard silt from the tributary of river Brahmaputra.
2. The areas covered and required levels may be mutually agreed as per site requirements. The rivers identified for pilot project for dredging are listed in **TABLE- I** appended below.
3. Providing all required tools, tackles, equipment, materials, supervision, labour, crane, grab bucket, boats, barges, de-mucking / submersible pumps and agitators, diesel compressors and all other sundry accessories and arrangements required to carry out.
4. Bidders have to manage all required permissions from concerned Govt. body without any extra cost to Water Resources Department, Assam. Dumping of excavated / dredged / barged silt should be at the designated location approved by Water Resources Department, Assam approved dumping ground.

B. BIDDER QUALIFICATION CRITERIA

An Expression of Interest (EOI) is sought from reputed dredging Companies with relevant experience subject to fulfilling the following criteria:

1. The bidder should have carried out 0.5 million Cubic meter of dredging per annum at least once during last 3 financial years.
2. Bidder should have at least 1 owned cutter and suction (C&D) dredger with all other required equipment like pontoons mounted excavator, crane, boats, barges etc.
3. The bidder should have experience of satisfactory execution of long term dredging contracts with leading companies.
4. The bidder shall have during the last three financial years an Average Annual Turn Over of not less than INR 50 Crores or its equivalent from dredging and other water sector related services.

C. EOI SUBMISSIONS:

The Company interested in entering into Agreement with Water Resources Department, Assam shall at least submit the following information:

1. Background of the company including company profile, key personnel, experience details in dredging & related services along with the copy of Registration Certificate in the country of Incorporation.
2. Details of the quantum of dredging they have carried in the last 3 years worldwide, with separately mentioning the quantum executed in India.
3. Details of the owned Dredgers and all owned fleet of equipment.
4. Copies of Profit & Loss Account and Audited Balance Sheets for last 3 preceding financial years.
5. Copies of major dredging contracts currently in execution and executed since last 3 years.
